THE LONG-TERM CARE OMBUDSMAN PROGRAM IS A FEDERALLY MANDATED PROGRAM TO PROVIDE ADVOCATES FOR LONG TERM CARE CONSUMERS THROUGH WHICH CARIE REPRESENTS MORE THAN 4,000 RESIDENTS OF 150 SETTINGS IN PHILADELPHIA. IN FY 2016, STAFF AND VOLUNTEERS HANDLED 156 COMPLAINTS FROM 96 CONSUMERS, MADE 498 VISITS TO LONG-TERM CARE PROGRAMS, AND PROVIDED INFORMATION AND CONSULTATION TO 384 INDIVIDUALS AND SERVICE PROVIDERS.
